

National Consultation on Empowerment of Older Women

The Center for Gerontological Studies, conducted a national consultation during 21st to 23rd in Trivandrum. Sri RN Mital, Dr P Vyasamoorthy, Sri Parameshwar Reddy and Prof Ramamurti were invited from AP. They participated, presented papers and took active part in discussions. Nearly 105 persons from all over India participated. It was a big gathering of sociologists, medical men, gerontologists, eminent persons connected with senior citizens movement, federations and confederations, NGOs etc Several rounds of discussions, brainstorming, lectures, and presentations were held. Many retired IAS officers, VCs and busy physicians spent their time with us. SD Gokhale, KR Gangadaran, Mala Kapur Shankar Dass, Sheilu Srinivasan -- all of NPOP Revision Committee took active part. It is the first time that problems of older women were discussed from NPOP angle.

Best Practices in other Senior Citizens Associations

You may be a member in some other Senior Citizens Associations also. Or your friends may be. Can you share with all the members some of the best practices followed by SCAs? For example I can cite a couple of them here:

What do most SCAs do to retain people? Give Tea / snacks towards the end of the program!

Look at what Jynana Jyothi, a senior Citizens Association in Bengaluru does. They conduct regular meetings every month. To motivate members to attend the meetings from beginning to end, one or two members are given a Lucky Winner Prize – Present for (mere) presence! This they do by giving a token to each member as he comes in; a lucky draw is made towards end of the meeting, say before vote of thanks. The winner(s) are given a

small token cash award. They lose it if they have gone away! Issue of tokens is stopped after a certain period say 15 minutes after scheduled start of the event. Late comers and early leavers stand to lose. This practice improves 'full time' attendance, provides some incentive.

How does an SCA instill a sense of positive mental attitude in every one of their meetings? Let is see what Senior Citizens Forum, Secunderabad does. At the end of every meeting a song composed by Sri Theodore Comfort, adopted as their "Association Song" is sung in chorus: "The Time to be happy is Now; The place to be happy is Here; And the way to be happy is to create a little heaven right Here" Who would not leave such a meeting in a positive mood?

Aadhaar ID Card

Aadhaar ID Cards which serve as multi purpose cards are being issued in the city in various centers. Have you applied for the same and got it? How about sharing your experiences in one of the forthcoming meetings? The residents will have to submit their name, date of birth, sex and address. They will also have to submit proof of identification and proof of address while filling the form. During the survey along with the above data, photo of a person, finger prints and IRIS image will also be taken. In case of proof of identity (POI), the citizens can submit PAN card, ration card, voter Id card, driving licence, and passport and so on. As a proof of address, the individuals can submit passport, bank passbook, post office passbook, ration card and voter ID card.
